

Nouveau Contour All Round Training in Permanent Cosmetics Terms and Conditions

1. Nouveau Contour Permanent Cosmetics All Round Training course consists of the following.
 - Pre-Study Training Course
 - Pre Study Practical Course
 - Pre Study Exam
 - Five days academy training
 - Apprentice period
 - Assessment
 - Post graduate workshop days
2. The first stage is to complete the Pre-study and practical courses which are home study courses and 2 days training. A short exam will also be taken at home before commencing the academy training. The cost for registration onto this course is £1000 + VAT. This includes Pre – Study and Practical training manuals, Nouveau Contour equipment supplied to enable the student to complete the Practical Course and the Pre Study and Practical Exam. This is a correspondence course and once manuals have been despatched, Nouveau Contour will be unable to provide any refund. You are also required to attend 2 training days before you attend the All Round Training Course. One of these days is designed to improve your drawing technique, the other is a health and safety and blood borne pathogens training course, where you will be required to sit an exam.
3. The second stage is to complete the All Round Training in Permanent Cosmetics five day academy training course. The cost for attendance on this part of the course is £3000 + VAT. No place on any course will be guaranteed until cleared funds and completed contract have been received by Nouveau Beauty Group Ltd. Places on courses will be allocated on a first come – first served basis.
4. Under the distance selling regulations (2000) you have the right to cancel the course within seven days of making the booking. All transactions are deemed to be business to business.
5. If you are unable to attend the course for any reason, Nouveau Beauty Group Ltd will be unable to provide any refund. A place on a future course may be offered if spaces are available or you may be offered a cancellation at short notice. If you are prone to illness, suffer repeated illness or have an on-going medical complaint which may affect your ability to attend a course, we recommend you take out adequate insurance to cover any loss. Nouveau Beauty Group Ltd will make every effort to accommodate your requirements. Priority will be given to existing confirmed bookings.
6. It is recommended that students enrol for the Pre Study and Practical Training courses at least six weeks prior to the desired commencement date of the academy training. This should allow adequate time to complete these courses. Nouveau Beauty Group Ltd will not accept responsibility for students who opt to undertake these courses on a more compact time scale and subsequently have difficulty in understanding the basic biology and beauty therapy procedures required. Should any student feel that they cannot proceed with the

training once they have started the course, no monies will be refunded by Nouveau Beauty Group Ltd .

7. At the time of booking, you must inform Nouveau Beauty Group Ltd which permanent cosmetics device you wish to purchase. Payment for the machine can be made in advance or whilst on the course. No machine will be issued until full payment has been received and funds cleared.
8. For trainees attending courses in Yorkshire, Nouveau Beauty Group Ltd will endeavour to provide all models for the training. Trainees attending courses in London will be required to provide their own models. A limited database of models may be available for London courses.
9. When sourcing models for training courses, please note, legislation states that it is not permitted to undertake permanent cosmetics procedures for anyone under the age of 18, even if parental consent has been granted. It is also strongly recommended that permanent cosmetics technicians do not undertake procedures for clients who are pregnant or breast feeding. Nouveau Beauty Group Ltd therefore regret that we will not allow under age models, pregnant women or nursing mothers to receive treatments on the training premises.
10. Nouveau Beauty Group Ltd will not be held responsible for the non-attendance of models and may, at the discretion of the trainers, take whatever measures are necessary to allow students to complete the course.
11. The third stage of the course is to complete twelve case studies during the apprentice period. This should consist four eyes, four brows and four lips procedures. This may be twelve individual clients, four clients having three procedures or any combination. Each procedure must be fully documented with before and after pictures.
12. Stage four. Students must attend an assessment day in order to obtain their certification. Models will not be provided for assessment days, students must source their own models. A demonstration of lips, eyes and brow procedures should be undertaken. These may be new procedures or re-touch procedures for clients used as models or case studies. Completion of stages one to four does not automatically guarantee certification. Trainers may request further case studies or that the student re-sits part of the course in order to meet the required standards. There is no additional charge for the assessment day.
13. A date for your assessment will be set during or soon after your training period. Should you fail to attend a pre agreed assessment date, you will forfeit your right to a free assessment. A charge of £500 + vat will be required to secure a new assessment date.
14. Students are entitled to two free workshops which must be taken within six months of completion of the academy training. Models are not provided for workshop days. Workshop days may be taken before or after the assessment day. Any model treatment undertaken on a workshop day should be fully documented and can not be submitted as case studies.
15. As part of the academy training and some workshops, students may be required to work on pig skin as a medium to practice machine control. Nouveau Beauty Group Ltd respects
